1	Page 56, clause 4.3 of Scope of Work - "Cleaning of Aluminium / Glass Facade. Equipment like <b>gondola</b> required for façade cleaning/aluminium panels cleaning shall be arranged by the bidder".	Page 56 Clause 4.3 may be read as - "Equipment like Gondola / Spider Kit required for façade cleaning/aluminium panels cleaning shall be arranged by the bidder.
2	Page 56, clause 4.4 of Scope of Work - "Equipment & Material to be provided by the Bidder".	Already defined in NIT Clause 4.4 to 4.6 of Scope of Work. Specific quantity of cleaning material cannot be specified as it depends upon the cleaning area conditions etc.
3	Page 62, clause 6.37 of Scope of Work "Qualification for housekeeping boys should be 8th pass."	On Page 62, clause 6.37 the qualification clause for 'house boys' stands deleted.
4	Page 70(ii), Plumbing services man- days=2190. SOR 5.2.1 Plumber man-days = 520 SOR 5.2.2 Helper man-days = 520	Page 70 (ii) may be read as - "SOR 5.2.1 Plumber man-days =1095 days" "SOR 5.2.2 Helper man-days =1095 days"
5	NIT clause - E (ii) (page-70) "Plumbing Services - No qualification mentioned for Plumbers".	NIT clause - E (ii) (page-70) may be read as - "The qualification for Plumber should be ITI pass or at least 05 years experience in relevant field".
6	NIT Clause - 12 'Taxes & Duties"	No variation is acceptable in 'Taxes & Duties" as the same has already been defined in NIT Clause -12 of Conditions of Contract.

NOTE: All other terms and conditions mentioned in NIT NO.14/17/2017-OIDB Dated 05.12.2017 shall remain unchanged.
