Contractor will take all necessary steps to deposit statutory contribution in respect of employees with concerned authorities and to ensure strict compliance of labour laws. This will be the responsibility of the contractor to comply with the statutory obligations related with the contract including the provident Fund (PF) and Employee State Insurance (ESI) for the persons deployed by the contractor. Contractor shall adhere to all laws, rules and regulations that may be in force from time to time concerning the employment or service conditions of their employees.
