### NOTIFICATION

G.S.R. 24 (E).—In exercise of the powers conferred by Section 31 of the Oil Industry (Development) Act, 1974 (47 of 1974), the Central Government hereby makes the following rules further to amend the Oil Industry Development Board Employees' (General Conditions of Service) Rules, 1984, namely :—

1. (1) These rules may be called the Oil Industry Development Board Employees' (General Conditions of Service) Second Amendment Rules, 1988.

(2) They shall come into force on the date of their publication in the Official Gazette.

2. In the Oil Industry Development Board Employees' (General Conditions of Service) Rules, 1984—

(a) in rule 2, in clause (b), for sub-clause (ii), the following sub-clauses shall be substituted, namely :—

"(ii) the Secretary, in relation to exercise of such power in respect of Group B Posts ;

(iii) the Financial Adviser and Chief Accounts Officer, in relation to exercise of such power in respect of Group C posts ;

(iv) the Senior Accounts|Administrative Officer, in relation to exercise of such power in respect of Group D posts ;";

(b) after clause (e), the following clauses shall be inserted, namely :—

- (f) "Financial Adviser and Chief Accounts Officer" means a person who holds, for the time being, that post in the Board ;
- (g) "Senior Accounts|Administrative Officer" means a person who holds, for the time being, that post in the Board."
