"It's unsafe to re cord the conviction on the basis of a dying declaration alone where suspicion is raised as regards the correctness of the dying declaration. The court may have to (then) treat the dying declaration only as a piece of evidence... Although the appellant-convict has been named in the two dying declarations as the person who set the room on fire, the surrounding circumstances render such statements very doubtful," it said.

"It is the duty of the prosecution to establish the charge against the accused beyond reasonable doubt... It is true that dying declaration is a substantive piece of evidence to be relied on provided it is proved that the same was voluntary and truthful and the victim was in a fit state of mind. It is just not enough for the court to say that the dying declaration is reliable as the accused is named in the dying declaration as the assailant," the bench said.


