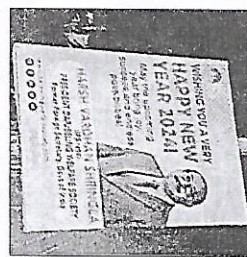
Buzz grows over Shringla entering IS election fray from Darjeeling

NEW DELHI: Could former foreign secretary and G20 coordinator Harsh Vardhan Shringla be a potential Lok Sabha candidate in 2024 from Darjeeling? Posters that emerged all over this West Bengal hill town over the New Year weekend have generated some buzz to the effect.

The posters, featuring the 61-year-old Shringla in a suit, in his avatar as president of the Darjeeling Welfare Society, and simply greeting everyone for the new year, seem innocuous. Still, the launch of the society just a year before the elections, in mid-2023, and the spread of the poster has everyone guessing.

On Tuesday, Shringla's only response when asked about the posters was a counter question - on whether there were a lot of them around town. In September,

after the launch of the society, he had brushed off a similar question, "Don't believe media speculation," was what he said then. The secretary of the society Dechen Chimi Wangdi said that the society's objective was to work towards the welfare of the people of Darjeeling.

The state Bharatiya Janata Party unit has supported the move. Party member Sanjib Bis-

was said: "All of us would want a professional after having seen politicians for the last three terms."

Another person keeping a close eye on developments is BJP's sitting candidate Raju Bisra. "I someone wants to dream about that seat, I will wish them well. According to Indian law, everyone has the right to contest," Only 37, Bisra was brought in to replace the party's veteran leader SS Ahluwalia from this seat in 2019. A Nepali-speaking Gorkha, he was considered more suitable for the region but he acknowledged that his ability to get things done has been limited due to the non-cooperation of the state government.

While Ahluwalia didn't confirm Shringla's candidature, he seemed supportive of the move. "Darjeeling needs a lot of development. Simply politics isn't going to work here. If you want to restore the lost glory of the town, you need a visionary who international expo-

sure," he said.

Local residents said for them, the long-pending Gorkhland demand is the poll key issue.

"It is the only agenda that is instrumental for any political move. BJP has failed to address the long-pending demand as did the Congress earlier. Whoever the candidate is, they should back the century long issue of Gorkhland, or else the leader will not be favoured by public in the long run in Darjeeling constituency," said poet Raju Punmi.

Shringla, whose father was from Sikkim, was India's foreign secretary between 2020 and 2022 and ambassador to the US between 2019 and 2020. He also served in Bangladesh and Thailand. Apart from G20 and his tenure as foreign secretary during the pandemic, Shringla worked closely with Prime Minister Narendra Modi during the "Howdy Modi" event in Texas in 2019.

Tech a great enabler but digital divide is real: SC

NEW DELHI: Although technology is a great enabler, digital divide is a reality too, the Supreme Court highlighted on Tuesday as it came to the rescue of a young man whose aspiration to join the police force in Bihar was crushed because of a typographical error - his online application form recorded his date of birth as '08/12/1997'.

Instead of "18/12/1997", noting that the "rarefied atmosphere of the cyber-enabled application process" has led to such errors, the court said that the applicant who hailed from a small village in Bihar and belonged to the down-trodden segment of the society, a bench of justices JK Maheshwari and KV Viswanathan directed the state government to issue an appointment letter to the petitioner and recruit him as a constable within four weeks.

"We further direct that in the event of there being no vacancy, the appointment letter will still have to be issued on the special facts of this case. We further direct that the state will be at liberty in that event to adjust the vacancy in the next recruitment that they may resort to in the coming years," said the judgment, authored by justice Viswanathan.

Vasisth Narayan Kumar, the petitioner, had applied for the post of constable in 2017 under the reserved category and cleared all the rounds of the test. Kumar was however declared as failed in his final result since his educational certificates mentioned his date of birth as '18/12/1997' whereas the application form that he had filled in a cyber café in a nearby town recorded his date of birth as '08/12/1997'. He filed the online form with the assistance of the person running the cyber café.
